Minutes

BOARD MEETING MINUTES 1/9/2018

Meeting called to order at 7pm by President Tom Desmond

Present: Artzer, Baker, Desmond, Faingold, Kohler, Mead, Patton

I. CALL TO ORDER

Pledge of Allegiance

II. AGENDA

1.9.18 a. Motion to approve agenda. Motion seconded and passed.

III. MINUTES

1.9.18 b. Motion to accept minutes - Correction to the minutes from 12/12/17 - Under Members Forum - AGC CRO Terry Humbargar suggested that if a member commits a minor safety violation to have them go through the safety class. **A member that breaks a major violation should get kicked out of the club**. Possibly doing the safety class for new members as part of orientation each year as a requirement was also suggested. **Correction:** The underlined should have read that if a member breaks a major violation they should go before the board and the board should decide their consequence, which could result in the member being removed from the club.

1.9.18 c. Motion to approve change Motion seconded and passed.

IV. MEMBERS FORUM

AGC Member, Matthew Hess – Requested the use of the Education Trailer to use for PSAC meeting after the match on Jan. 27th at 1:00 pm. He also made a request for funds to build two - three more tables. PSAC uses these tables during their match to store gear. He is willing to donate his time to build the tables but needs \$225 for materials. After more discussion it was decided to build 3 more tables.

1.9.18 d. Motion to accept Matthew's request

Motion Seconded and passed.

Matthew also asked about getting the berms restored, as they have continued to erode over time. AGC Member, Conrad Holland could come out and rebuild the pistol berms, as he has done this in the past. Need to have not quite as much of a crown on the top of them when done.

One of the AGC's RSOs in attendance addressed the ice on the magnum handgun range as a result of the drainage from the caretaker's house. Discussion about a possible French drain style system could be installed.

AGC Member, Willie Chatman – Let the board know that he could get 7 ft. barriers donated to the club. The barriers could go towards the end of the property where the RV storage is going in. The club would need to get sand to fill them and a bobcat to move them. The board would first need to get approval from the city to put up the barriers. He also asked if a soldier would like a place to shoot can they come here to shoot? It was discussed that most shoots have non-members that attend the different shoots, so they could join the shoots. It was also discussed that if they are Active Military Duty the fees would be waived.

V. OLD BUSINESS

<u>Financial Report</u> — AGC Treasurer, Loren Kohler — In December our revenues were \$39,284 (which included the \$21,246 from lead removal in trap range) and our expenses were \$20,965 leaving a net gain of \$18,319. Our YTD revenue is \$306,528 and our YTD expenses are \$233,419 leaving a net gain of \$73,109. Account balances: Checking Account \$200,293; Payroll Account \$7,158 and Savings Account \$728,101. Our assets with the JP Morgan Cash Holdings account is \$6,001. Our Fixed income account balance is \$125,086. Our Alternative Assets balance is \$122,819. Total JP Morgan is \$253,906

<u>Maintenance</u> – AGC 2nd VP, Berry Patton – We are currently working on the clubhouse kitchen, the demo is done, and we have begun putting it back together. When it is complete it will look like a residential kitchen.

<u>Cell Phone</u> – AGC CRO Terry Humbargar – Had a meeting with the Range Officers, looked like the best option was to get a phone at Wal-Mart and just purchase minutes. Cost \$150.00 total. Questions were asked about whether a shooter should be asked to call the Range Officer first or 911. Concerns about telling members to call the Range Officer first could pose as a liability. 911 should be called first and most likely the operator will stay on the phone until 1st responders arrive. In theory it might be a good idea for Range Officers to have a cell phone, but could potentially pose a problem if members do not contact 911 first. Discussion on the topic was closed at this time.

<u>2018 Calendars</u> - AGC Secretary, Steve Artzer – Shared the 2018 calendars with the range activity schedules – A few changes need to be made, some classes need to be added and a couple dates changed.

Renewal Update – Carla Smith – The renewal process has now been completed and 960 members have renewed, including 29 Life members. There are currently 67 openings for new members. This year the process took a little longer, as the club is moving to a database system.

<u>Safety Program Update</u> – AGC Board Member, David Faingold announced that the first firearm safety meeting was held. They watched firearm safety video from other clubs, and all agreed that putting together a safety video unique for AGC was a good idea.

Additional ideas such as using the video for all new members at orientation, and possibly a punitive tool along with a test for those members that break the rules would also be a good use for this type of video.

Logistics of showing the video were also discussed. Concerns that possibly a mandatory safety program might insult long time members was also brought up. Other ideas such as using incentives to get membership to corporate, and excluding long time members of AGC were also discussed.

Board members are going to review the videos, so that a script unique to the AGC can be developed.

David Faingold said that as a former member of the Tri-Service-Sportsman's Club at the Buckley AFB all members were required to take the safety class every two years. This is where the idea for AGC's safety video developed in light of some violations that had been made over the past. The idea being, keeping AGC a safe place to shoot while helping us to stay away from possible litigation, a tragedy, and closure or relocation of the club.

A member asked a question about having members sign off that they have read the rules. The members get a copy each year, but maybe they need to be held more accountable on making sure that they acknowledge them. Also, maybe offering an incentive (credit on dues) for members to attend the video screening may increase attendance. Making it mandatory for all members did not seem fair.

The board would like to first see a script written up to see what topics would be discussed and how they would be presented. Then few a couple of the videos that were shown. The board will then decide whether to approve and move forward. Would possibly like to set this up to have members take the course every 3 years. Last major violation was a year and a half ago. Some board member did not feel an incentive should be given, as it is up to members to keep their club safe.

VI. NEW BUSINESS

<u>Incident Report</u> – AGC CRO Terry Humbargar - No major violations to report – However, members are driving their truck down on the 200-yard range, which is not safe and need to address this concern.

It was discussed that range officers need to do a meet & greet with members and check their badges and tickets. Range Officers are no longer writing down information but should be verifying members information.

Concealed Carry Class - AGC Member, Nate Oldorf - Proposed holding a Concealed Carry Class - He is a Rifle, Pistol and Shotgun Instructor, has a law enforcement background and is certified by NRA to conduct concealed carry classes. Class would cost \$45 - \$50 for members. Add some time for range use. The class would cover the state requirements and statues. Classes would be on the weekends and last about 4 hours. This would be for members ONLY! There was discussion about the concern of liability coming back on the instructor and the club by offering the class. The board will contact the insurance company to check on the Liability piece.

Board Conflict of Interest - AGC Board President, Tom Desmond - The current board has signed and dated with today's date.

VII. ROUND TABLE

AGC Board Member, John Mead – Announced that the hearing for the North property is still scheduled for the January 16th. If anything changes, we will get an email out to members.

We started the day with the Barricades. We had one new shooter, Scott Schomer. Scott runs a combat competition event at the Arvada Gun Club so he is pretty familiar with competition. 
