AGC BOARD OF DIRECTORS MEETING MINUTES 2/10/2015

Meeting called to order at 7 PM by President Emmanuel Boyd.

Present: Anthony, Artzer, Baker, Bonner, Boyd, Desmond, Hirsch, Mead, and Price.

IV. MEMBERS FORUM

AGC Member, Bob Smith - I am against a rule change allowing members to shoot steel in berms 1 and 7. The splatter from shooting steel on these berms will shut this range down. We are having splatter problems on all ranges where we shoot steel. AGC Member AJ Davis suggested that we put up shields on the areas that are having issues.

AGC Member, AJ Davis - On the 200 yard range we need to add filler in front of the targets. If we can get old pavement, clay targets or rock, I will haul it and fill in these areas.

V. OLD BUSINESS

Maintenance - AGC 2nd VP, Dave Bonner - Someone hit our mailbox. We put up a new post, mailbox, and sign. I was contacted by a member who is a retired weed control person. He said that if we purchased a sprayer to attach to our tractor, he would come in and spray for weeds. The furnace in the Education Trailer was not working. Miller moths are getting into the intake and exhaust; causing the thermal coupler to burn out. We will have to seal up the intake and exhaust openings so this doesn't happen again.

Finance Report - AGC Treasurer, Tom Desmond - In January our revenues were \$15,487.43 and our expenses were \$19,016.82; leaving a negative net change of \$3,529.39. I just paid \$16,712.73 in property taxes for 2015. In January, the unrealized gain on our investment account was a loss of \$5,110.39.

New Member Orientation - AGC 1st VP, Chris Baker - This past weekend we held 4 orientations and have 4 more scheduled for next weekend. I want to thank board members, John Mead and John Price for making all of the calls to the people on our wait list. We went through 156 names to fill the 105 openings. I also want to thank Range Officers, Terry Humbargar and Bob Smith for coming in to help with the tours.

Review of Revised Discipline Match Policy and Safety Violation Report - AGC Secretary, Shirley Anthony - For now I want to hold off on the Discipline Match Policy. I want to make sure that we implement any rule changes into this policy. I would like the board to look over the Safety Violation Report and determine if the changes were correctly made.

200 Yard Military Match

Winter is almost over. Our first match of the year will be on Saturday March 7th @ 0900. This will be our annual Al Meader Spring Match and we will be going into our 20th year. We will be following our regular match format. This is a 20 round slow fire match off the bench. 2 optional sighters may also be fired. Front/rear rest are allowed.

To qualify for the end of the year awards, you must shoot in at least 5 of our 8 matches. If you shoot in all 8 matches, we will count the 5 highest scores. The last match of the year is the Jess Adams Outlaw Sniper Match in November. This match is scored separately.

This year we are adding a scoped military class. 4x scopes are max. Rifles must be WWII or earlier. Rifles must be original military rifles with only the alterations necessary to add a scope. All regular match rules apply except scope rifle shooter will be using another target.

The side match for March will be a Military Pistol Match. Randy has a special target for us. WWII Model pistols or earlier will qualify. This is a 20 round match.

If you have a military rifle or pistol and don't know if it qualifies for our match, give me or Steve a call. We will evaluate it.

Side matches are held after our regular match. Scores don't count for our end of the year awards.

CMP Rimfire Sporter Matches

A record turnout of 12 riflemen participated in our first CMP Rimfire Match of the year on Valentine's Day. It was great to see new and seasoned shooters turnout for the beautiful weather and post some pretty respectable scores. Our match tests your ability to shoot from prone, seated and standing positions, and allows for a low cost alternative to High Power/CMP Garand matches. Total time for the match was about 2 hours, and was won by Doug Ruegg shooting a Ruger 10/22. Scores for all participants were as follows (600/60X = perfect score):

Our next match is scheduled for March 14. Sign in at the 100 yard range will begin at 8:30, and the first rounds will go downrange at 9:00. The regulation match is shot with any commercially available .22LR rifle (any action type) that weighs under 7.5 pounds (including scope/sights), but we will welcome all .22LR shooters for this unsanctioned event. The course of fire is 60 rounds (+ unlimited sighters): 10 rounds slow fire and 10 rounds rapid fire in the prone, standing and seated positions. The only gear allowed is a rifle sling, shooting mat, spotting scope and a leather work glove for the support hand. Cost: Members \$5, Non Members \$10. This match is a great way to practice your high-power skills or to get acquainted with CMP/Military style shooting on a low budget.
