AGC BOARD OF DIRECTOR'S MEETING MINUTES 4/12/2011

Meeting called to order at 7 PM by President Mark Harper.

I. CALL TO ORDER

Pledge of Allegiance.

II. MINUTES

No corrections to the Minutes from BOD Meeting 3/08/2011.

04.12.11.a Motion to accept the minutes from the 3/08/2011 BOD meeting as stated. Motion seconded and passed.

III. MEMBERS FORUM:

AGC Member: Asked if it was possible to permanently cover the benchrest area on the 100 yard range. This area is in the flood plane and would possibly work better to put up a temporary covering. There was discussion about putting up framework and covering it with a sun resistant material that could be taken down in the winter and put back up in the summer. The BOD would like to invite all members to the May BOD meeting to get input from all that use this range.

AGC Webmaster, Fugi Silva: Asked if he should remove 3 Gun information from our web page. Since they no longer use our range, that information needs to be removed.

CRO's Corner

This month I wanted to talk about targets for a moment. First of all, the Aurora Gun Club only allows targets made from three materials. Those materials are paper, clay and steel. With Steel targets only cast or frangible bullets should be used to help prevent any part of the bullet from leaving the impact area. Jacketed bullets can come apart after impact with steel causing the core or the jacket to fly away, cast bullets tend to mushroom and drop off the steel. Steel targets should be angled slightly downward facing the shooter so when the target is hit the bullet deflects down and not to the side or up. Paper targets can be of almost any size and shape and include any material that can be printed on such as the peel and stick targets etc. Clay targets are of course clay pidgins, rabbits, minis and battues etc. Shooters may use clay targets with rifles and pistols if the targets are placed on a target stand or directly on the berms of the rifle and pistol ranges.

All targets should be placed either directly on the back berms or suspended in/on some sort of target "frame" that is placed as close to the back berm as possible. No shooting at targets placed on or in front of the side berms is allowed. Target frames/holders should be made of wood or material that has no chance of deflecting bullets. PVC pipe, thin walled aluminum tubing (found on commercially available target stands) and very small gage wire are permissible target frame materials. Any materials such as targets and frames that are accidentally struck by a bullet and fragmented should be cleaned up after the shooting session and not left on the ranges.

I encourage the use of creative targets, frames and sets. A clay bird suspended on a string for example can provide a moving and challenging target. Creativity can enhance a shooting session and hone one's skills with a firearm. Care must be taken with all target placement such that the bullets impact the center of the back berm after they pass through the target/frame. If you change shooting position always check target height to ensure the bullets are still going to impact in the center of the berm BEFORE you start to fire again. Please do not bring any other "targets" to the range to shoot, such as the old computer you hated, any trash or what not. Only Paper, Clay or Steel targets please.

Finally, please never shoot at any club property such as benches, signs, target stand tires, and so on. I have to mention this because we continually find bullet holes in club property. I also wish to clear up a misconception. The AGC does NOT provide targets for individual shooters nor has it ever done so to the best of my knowledge. There may have been an instance where an individual shooter was allowed to shoot a match discipline target while a match was being held but targets are not provided outside of matches for any shooters. The AGC does provide tires for 2" x 4" target stands at all ranges except the 200 yard range where a target frame is provided. These devices are to hold target stands and targets that the member or guests provides themselves. Thank you all and have a safe and enjoyable May!

May Military Rifle Match

Our next match (weather permitting) will be May 7th on the 200 yard range. Start time is 0900. We will begin with a safety briefing and explanation of the course of fire. Match is open to all as-issued pre-1955 military service rifles or their civilian production equivalent. As-issued means no match components or bedding of the action is allowed. Iron sights only. Ammunition may be G.I. Ball or equivalent hand loads. Target will be the NRA SR target. You will need a minimum of 35 rounds.

<u>Course of fire Bench Rest Division</u>: 10 rounds off the bench in 10 minutes, slow fire. 10 rounds off the bench in 5 minutes, rapid fire. Competitors will begin the rapid fire string with either 2 or 5 rounds loaded in the rifle. Sand bags or rifle rests are allowed, but no sleds or any support which holds the rifle in an artificial manner.

<u>Course of fire Position Shooting Division</u>: 10 rounds standing to prone rapid fire in 80 seconds. 10 rounds standing to sitting slow fire in 10 minutes. Shooting coats, shooting mats and kneeling rolls are allowed. The use of cotton, nylon or leather 1907 slings is allowed.


Centerfire Bench Rest Match
