# **Minutes**

#### **BOARD MEETING MINUTES 7/12/2022**

Meeting called to order at 7pm by President, Tom Desmond

Present: Boyd, Baker, Hay, Whitesides, Faingold, Kohler, Desmond and Caraway

Absent - Dobbs - unexcused

#### I. CALL TO ORDER

Pledge of Allegiance

#### II. AGENDA

**7.12.2022 a**. Motion to approve agenda Motion seconded and passed

#### III. MINUTES

**7.12.2022 b.** Motion to approve minutes from 6/14/2022 BOD meeting Motion seconded and passed

#### IV. MEMBERS FORUM

Bob Steil – Bob said that Randy Still ran the magnum handgun matches years ago and he made a lot of improvements during that time. He would like to recommend naming the magnum berm after Randy and call it the "Randy Still Magnum Handgun Berm". Bob also said Randy did a lot of work in the berm to make improvements as well. The board will consider his recommendation and talk next month.

Steve Chagolla – Steve said he would like to have Bob Smith mentioned in the newsletter because he goes out of his way to pull weeds around the club and empty trash cans when he is out shooting. He would also like to recommend that Dave Hay be made the Assistant Chief RO. The board will discuss during the executive meeting.

#### **V. OLD BUSINESS**

<u>Financial Report</u> — Treasurer, Loren Kohler – June revenues were \$24,337 and our expenses were \$23,223 with a net gain of \$1,114. Our YTD revenue is \$162,031 and our YTD expenses are \$132,432 with a net gain of \$29,599. Account balances: Chase Checking Account \$72,736; Chase Payroll Account \$16,171 and Chase Savings Account \$391,998; Bank of the West Money market account \$208,552. Loren said he looked over the bank statement and income statement and there was nothing out of the ordinary to report.

Maintenance Update – 2<sup>nd</sup> VP, David Faingold – David said Dave Leiker asked him to speak on his behalf regarding the clubhouse update. He said inspections are scheduled to be done at the end of this week and the contractor will start on the concrete work next week. Dave Hay asked what the schedule is for the inspections. David said it should be listed on the Arapahoe County website. David also said Liberty is sending a representative out to talk about servicing the porta potties. Then David spoke regarding the main gate situation and the company that services the gate sent out a representative to look at how it is operating. The representative said the circuitry of the gate is in the sensors underground which connects to the actuator for the gate. He said when the gate is tied open, it prevents the loop from circulating fully and the actuator continuously runs which blew a fuse and offset the timing that the gate is setup to open and remain open when people drive through. The company said this could be the reason the gate was prematurely closing. The gate company plans to install a

power switch which will help with keeping the gate open if needed. Dave Hay had a question about the person that comes out to the club with the front loader to groom the berms and wanted to know if we have a contract with them. He was asking because he said when the berms are groomed it disturbs the weeds and makes the dirt loose because there is nothing holding it in place. David said we are not under contract and the guy comes out twice a year. Matthew Hess (in attendance) said they have tried netting and seeding the side berms and the soil is just too loose. David said he can hold off on asking the guy to come out in September to groom the berms.

<u>PSAC Conex Storage</u> – President, Tom Desmond – Matthew Hess said he would like to consider getting a larger storage unit but will need to check pricing to make sure it is still in their budget. He also said that PSAC will not get insurance for the unit and AGC will not be required to insure it either. Matthew will get a release of liability form releasing AGC from any liability for any damage that could happen to the unit or its contents.

<u>First Aid Update</u> – 1<sup>st</sup> VP, Chris Baker – Chris provided a brief update that he received from Emit regarding the first aid classes. He said the classes would be scheduled during the week and weekends for those that are required to attend. His only concern is the length of the class so he needs to speak to Emit. Chris feels that we may be going outside the scope of what he thought would need to be done with regards to first aid for the club.

<u>Clubhouse Renovation Status</u> – President, Tom Desmond – See Maintenance Update in Old Business.

<u>Summer BBQ Update</u> – Manny Boyd/Dietrich Whitesides – Manny said the food and tent have been finalized for the BBQ. Food for 215 people has been ordered. He would like to ask if there is anyone to help setup that day, please come out the club before. Dietrich said he will be out of town and unable to help that day.

#### **VI. NEW BUSINESS**

<u>Incident Reports</u> – President, Tom Desmond – Steve Chagolla said there was an incident the day before where the main gate malfunctioned and closed on a member's car as they were driving in. David Faingold contacted the gate company as mentioned in the Maintenance Update. Steve told the member to get 2-3 quotes to have his car repaired and turn them in to the board for review.

Review August Calendar – Nicole Quiring reviewed the August calendar. Tom asked Nicole to update the message at the top of the calendar for trap and add Wednesday trap back on Wednesdays. Dave Hay asked why the trap costs could not be \$4.00 every day and Loren said it cannot be that amount because the club would lose money. Loren said we need to look at trap costs when we order the next trailer.

#### VII. BOARD ROUND TABLE

Mel Caraway – Mel is not in favor of raising the trap costs for all days and he thanks Dave, Sonny and Steve for their help with Wednesday trap. He said Wednesday trap is going well with more shooters. Loren asked Clubhouse Manager, Stephanie Hughes if she recalls the revenue for Wednesday and she said it has fluctuated over the last month.

David Faingold – David said he spoke the videographer regarding the safety video and members can watch when they renew and have a 4-5 question exam after viewing the video. David asked Tom if he would work on it or the club's web master. Martin Tritschler (in attendance) said he sent an email to the board asking why the safety video was needed. Loren said in the past they had a skeet club at Buckley Air Force Base and people that would attend the shoot and go on base had to take a safety class every 2-3 years. Loren also said the safety standpoint here is we have an orientation when you first join, and an ongoing safety video would help refresh members in safety. David said the video will help people that may not have experience such as military, law enforcement and he is noticing a lot more complacency, and we are one bullet away from being shut down. Martin said he reads the newsletter on a regular basis and there are very few people that have had safety issues at the club. Steve said that there are more issues than what is in the newsletter and the ROs help educate members to correct the problems. Martin does not personally agree with the video but respects the idea and would like for it to be made accessible to members in a reasonable fashion to view. The topic will be added to the agenda for August or September to discuss before renewals.

Manny Boyd – Manny would like to discuss the AR-15 military shoot on behalf of Willie Chatman. Willie would like to add members to the shoot that was discussed last month. The board agreed to let Willie add members to the shoot and he will determine the number of member participants.

Loren Kohler – Loren said he was under the impression that the costs for birds are going up and we need to consider raising the cost of trap now to help members adjust to the increase when the new trailer is ordered and would like to raise all trap fees except Wednesdays.

Tom Desmond – Tom said he would like to have an executive session at the end of the meeting. Tom also asked about the cost of trap coins.
