## AGC ANNUAL MEETING MINUTES 10/1/2017

Meeting called to order at 11:00 am by President Emmanuel Boyd

Present: Artzer, Baker, Boyd, Desmond, Faingold, Kohler, Mead, Patton,

Absent: Hirsch

### I. CALL TO ORDER

Pledge of Allegiance

### II. AGENDA

No agenda

**III. OPENING** – AGC Board President, Emmanuel Boyd – I would like to welcome everyone to the AGC Annual Meeting. This meeting will be conducted similar to our monthly meetings. Your suggestions and comments are welcome, but there will be no motions and no agenda to follow. Members are also welcome to attend our monthly meetings, which are held on the 2<sup>nd</sup> Tuesday of each month. We did not hold an election this year due to having 3 open seats and only 1 candidate. It just did not make sense to spend the club's funds for one candidate to be elected. Part of the boards responsibilities are to make sure that funds are spent wisely.

### IV. OPEN MEMBERS FORUM –

Discussion about the status of Bison drilling company. – AGC Board President, Emmanuel Boyd – Explained that the club signed a 3-year contract. The derrick will be placed approximately 1-mile South of the club, but not on the club's property. There will be no equipment on our property. The drilling will be done all underground. Construction of the derrick has not begun yet. Once they start drilling if they hit oil then the club will begin receiving royalties.

Question about paving the entrance. - AGC 2<sup>nd</sup> VP, John Mead – Barry and I have gotten a few bids to do the front entrance. Bid of 34,000 has come in so far. There will be a company coming out to work on Gun Club Rd., to make improvements where the road always floods. We are going to check to see if we can get them to do the work for us while they are out here. May be more cost effective that way.

Harold Lee – Would just like to thank you for cleaning up the 100-yd. range.

Will the renewal process be the same? - Renewal invoices will be sent out as usual, the only change is that members will have the option to pay online if they choose.

AGC Board President, Emmanuel Boyd – I would like to thank Bill Chin for the work done on the 200-yd. range, and for putting together the Military Match, as he is getting a lot of shooters involved.

Credit Card Processing - AGC Treasurer, Tom Desmond – We will be finalizing the invoices and sending them out by the end of this month. The option to pay online will now be available for those members that would like to pay online. There will be a service fee, which is standard with credit card charges. It will show your total due before making the payment. You will then receive an email that your payment has been paid. Carla will also receive an email showing your payment has been made. You will still need to sign your Liability Clause on the back of the invoice and mail it back in.

Addressing members in attendance: Has anyone signed onto the database yet? 1 member had signed on. Please follow the directions in the newsletter to check your information to make sure your address, phone, email and emergency contacts are correct.

AGC 2<sup>nd</sup> VP, John Mead – Southeast Metro Storm Water – They were looking at possibly doing a bridge, but they have decided to work on the road where it dips down into the stream area. They will be east of the 200-yd. line. We may have the opportunity to build up our berms.

AGC Board President, Emmanuel Boyd – Regarding the 10 acres that we were trying to acquire, we will not be able to. It is currently under contract for \$585,000. They have 5 acres that are in a flood zone. Once we hear of a hearing we will keep you informed. We would like to have several members attend the meeting. There has been discussion about the other neighboring areas not wanting to see any RV storage parks move in the area.

AGC Board President, Emmanuel Boyd - Clubhouse Manger – Ladies and Gentlemen I would like to take a moment and introduce our new clubhouse manager her name is Adrienne.

Question about getting the floor in the clubhouse painted. AGC 2<sup>nd</sup> VP, John Mead - Stated that he would prefer to get it done professionally and have it done during the winter months would be a better time.

Safety Issues – CRO Terry Humbargar – He would just like to stress the rules of the club and that everyone needs to follow them. People have asked him if we will be offering range officer classes again?

## 10-1-17 Annual Meeting Minutes Cont...

AGC Board President, Emmanuel Boyd – Announced that there are 4 spotting scopes available for members to use when members forget to bring their own. Members may borrow a scope from the clubhouse by completing a sign-out sheet and leaving their driver's license in the clubhouse, which will be returned when the scope is brought back. A sign-out sheet will be kept, so we may track how many times the scopes are being used.

Concern of muzzle control and accidental discharges, especially with our neighboring areas only about 1 mile away. Would like to make sure that shooters are using the correct targets when shooting.

Question came up about the possibility of berm #7 being used for PSAC, since PSAC brings in money for the club. AGC Board President, Emmanuel Boyd – PSAC is great and I use it as my safety example. However, it is the membership here that is our main concern. We would like to keep this club for the members. Many members can only come out on the weekends and we want to make sure that they have a place to shoot.

AGC Administrative Assistant, Carla Smith – Asked members to please read the newsletter, as there is lots of good information and updates.

AGC Board President, Emmanuel Boyd – We have unfortunately lost a few members this year and I would like to ask Bill Chin to help keep us informed as things come up. Many of these are members that had been here for a long time.

Email Information - AGC Treasurer, Tom Desmond – There have been a few people that have unsubscribed from the MailChimp email list. If you choose to unsubscribe you will not receive any emails. The reason we changed was that the old email system would block sending the emails if one members email had changed and made it very time consuming to send the newsletter or notifications to members. If a member unsubscribes they will need to sign themselves back up, as we cannot add them back on the list.

## IV. MEMBERS FORUM

AGC CRO Terry Humbargar – I would like to say, “thank you” to Emmanuel for serving on the board for the past 9 years and past 4 as President.

AGC Outgoing President, Emmanuel Boyd – Bill Chin is requesting \$250 for trophies for the Military Bench Rest shoot.

AGC Outgoing President, Emmanuel Boyd – I also had a member talk with me about the fence line on the parking side and a concern of backing into the fence.

## V. OLD BUSINESS

Financial Report — AGC Treasurer, Loren Kohler — In September our revenues were \$17,492.52 and our expenses were \$17,417.32 leaving a net gain of \$75.20. Our YTD revenue is \$230,474.60 and our YTD expenses are \$175,664.99 leaving a net gain of \$54,809.61. Account balances: Checking Account \$117,214.23; Payroll Account \$14,938.67 and Savings Account \$682,963.00. Our assets with the JP Morgan Cash Holdings account is \$14,221.69. Our Fixed income account balance is \$142,260.88. Our Alternative Assets balance is \$97,047.50 Total JP Morgan is \$253,530.07.

Maintenance – AGC 2<sup>nd</sup> VP, Berry Patton – We will be having a company come out and fix the drive at the front entrance. There was discussion about redoing the driveway area and not just patching holes. There is nothing new to report on the north property. Southeast Metro Storm Water will be working on the renovation of the stream and will need to be on the property. The roof on the education trailer is being looked at, so that it may be fixed.

Voice Response System - AGC Treasurer, Loren Kohler – Was asked to bring in pricing and more information on the system before a decision is made. Would like to dedicate the non-wire system to field #2 for voice calls.

Update on Bison Oil & Gas – AGC Outgoing Board President, Emmanuel Boyd - Not much more to report at this time. The contract has been signed, received initial payment, now just waiting to see if they hit oil. They will be located south of us, but not on the club's property.

## VI. NEW BUSINESS

Incident Report - AGC CRO Terry Humbargar – Each range officer received a winter jacket, so that range officers can be easily identified. The cost of the jackets was \$86. There was a member on a berm who was shooting too low and it was addressed and taken care of. There has been discussion about RO training. We did have one volunteer that worked off his dues as a RO. However, backup RO's need to be trained. We will be holding first aid classes at the beginning of the year with the Fire Department. When Mike Nagengast moves Paul Lundberg will take his place for the Military Bold Action Bench Rest.

Vacant Board Positions – There are 2 vacant board positions. Members are welcome to submit Bios or resumes to the board.

Board Incentives – AGC 1<sup>st</sup> VP, Chris Baker – It was stated that Past President is to receive half off of their club membership dues and for all board members, while serving on the board, dues are waived in lieu of the board service. It was proposed that a board member that serves 3 years on Executive Board could receive half off dues. A Board member that serves 2 terms on the Board could receive half off dues. These were proposals suggested as a way to have members more interested in serving on the board. The discussion was tabled to be discussed at a later date.

Discipline Open House – AGC 1<sup>st</sup> VP, Chris Baker – discussed having a “Discipline Open House” where members could try a discipline for free. Target date is June 30<sup>th</sup>. Will put out signs to notify. The notice would also be put out to the public for people to come try out. Will discuss this again next month.

Reclaiming Lead on the Trap range – Board Member John Mead – A company is offering a lead retrieval contract for the Trap range with a 60/40 spit. It has been several years since this was done and they expect two truck-loads of lead is available for recovery. Motion made, seconded and passed to approve the contract.

Review of November Calendar - Novice AR is cancelled until Spring. PSAC will move to 7:30 am after time change.

## NRA Action Pistol

It seems like the worse I feel after a match the better time I have had. I can usually tell how I feel about the time I hit the gate to go home what kind of day it was. With tired legs and feet, a sore back and sun and wind burn I can tell it was a great day shooting with great people!

We started off the morning setting the courses up. Most of our shooters have a lot of experience in the set-up and it went quickly. I am always amazed at the team work displayed by the Action Pistol crowd. Even if someone is a little under the weather and unable to lift the steel plates or target stands they jump right in to mark the yardages, staple cardboard backstops or whatever needs to be done to get the match rolling.

This month my wife decided a big pan of cinnamon rolls would be just the ticket to start the match off on a positive note. And she was right! Add a cup of coffee to that and we were off to a great start. The weather contributed to the appreciation of having something warm and sweet to start the day off with.

The first stage of the match was the Barricade event, featuring barricades with targets out to 35-yards. It was a little cool and breezy until about half-way through the event. Then a fog bank rolled in with colder temperatures and even more wind. Since we don't usually get this kind of fog it was unusual. Not enough to stop the safe shooting but it did make for some interesting conditions. You might think that adults would have enough sense to not shoot in bad weather but that didn't stop us. Dietrich Whitesides summed up the groups feelings when he said, "If it isn't raining it isn't training!"

About the time we finished the Barricades and went to the Falling Plates the wind had blown the fog bank through and we had sunny skies but cool and windy conditions. But no one was going to complain or give up. Hitting those 8-inch steel plates out to 25 yards in a lot of fun, but way too often a humbling experience. It is sometimes hard to remain focused as there are always some good-natured comments pertaining to a shooters skills, or lack thereof. If you have never shot the falling plates you really need to give it a try.

We finished the day with the Practical event. Watching marksmen hit a 4-inch circle or even just the target out to almost 50 yards is a rewarding experience. The wind was strong enough that it actually blew some of the targets over. But we managed to get through the stage none the worse for wear.

One good thing about shooting with this crowd is there is always a lot of creative problem-solving. It looks like with a little PVC and some weights we will have improved target stand system for the November match. The suggestions prompted a lot of, "now why didn't I think of that!" looks.
