I. Call to Order - AGC President, T. Desmond

II. Agenda Approval - AGC President, T. Desmond

III. Introduction of Board Candidates - AGC President, T. Desmond - changed to Dave Carriker

Dave Carriker - Today is our Annual Election day. The polling will end at 1:00 pm and the ballot box will be picked up at that time.

Candidates in attendance briefly spoke:

Mel Caraway – Introduced himself and asked what members would like to see the board accomplish? No one really had anything specific. He said that he would be honored to be on the board.

Ron Dobbs – Not in attendance

Tom Desmond – Most of the members know me by now and know the different items that I have accomplished for the club. I have done a lot and would like the chance to continue to serve on the board.

Rich Russell - Not in attendance

Emmanuel Boyd – I would like to continue to see the club do well and keep it a safe place for shooters to enjoy. I will continue to help wherever I can.

Matt Hailey – I have been a member for 2 years. I believe that if you find something you enjoy then you should get involved. I would like to continue to keep the club doing well and going in the right direction. I am a Licensed attorney, have an undergrad in finance, and live about 10 minutes from the club.

The ballot box will be taken out of the clubhouse at 1:00 pm. The board will reconvene shortly after 1:00 pm.

IV. Recess from noon until Election counting is complete

V. Meeting resumed shortly after 1:00 pm. Dave Carriker announced the results of the Election. 1st Place Tom Desmond with 242 votes - 2nd Place Emmanuel Boyd with 213 votes and 3rd Place to Mel Caraway with 172 votes. An email will be sent out to members.

David Faingold announced that he too would not be at the Board meeting on Tuesday and gives his proxy if needed to Michael Quiring.

Tom Desmond thanked former board member Steve Artzer for his service.

II. AGENDA

10.8.19 a. Motion to approve agenda adding under New Business – Target stand alternatives and to strike approving the Annual Meeting minutes until next month, after they have been published in the newsletter.

Motion seconded and passed

III. MINUTES

10.8.19 b. Motion to approve minutes from 9/10/19 BOD meeting

Motion seconded and passed

IV. Election Results – Dave Carriker shared the results of the Election with the board and thanked all the members who helped with the counting process (Mike Ben-skin, James Carriker, Steve Chagolla, Charles Clemenson, Greg Sether, Fred Smith, Chuck Steinman, & Tom Wengh, also Administrative Assistant's Carla Smith and Nicole Quiring. This year's Election had the most ballots received and the information has been posted on the clubhouse door, the bulletin board and the door to the stat house.

V. Appointment of Executive Board – Tom Desmond asked who would like to take over the Secretary position – Michael Quiring volunteered to do the Secretary position and Dietrich Whitesides also volunteered. The board decided to take a vote. Michael had to delegate the proxy votes that he had been assigned by the two absent members to other board members for this particular vote.

10.8.19 c. Michael made the motion to delegate Loren Kohler's vote to Tom Desmond and David Faingold's to Mel Caraway.

Motion seconded and passed

The board then voted, and Michael Quiring will take over the Secretary position. It was then decided that Loren Kohler is to remain as Treasurer, David Faingold to remain as 2nd VP of Maintenance, Chris Baker to remain as 1st VP, and Tom Desmond to remain as President.

VI. MEMBERS FORUM

Member and RO, Pete Benoit – Proposed to the board to please consider increasing the membership of the club by 50 or 100 new members. He feels that the club is not nearly as busy as it once used to be and that there are some members who hardly ever use the club. Adding just a few at a time to see how many new members they could add without impacting the club. He asked if a report could be run to see how many times a member signs into the club throughout the year? He stated that this club is not being utilized the way it should be and that there is room for more members to shoot. Possibly adding 100 new members this next year would be a good start. No current members would lose their membership, as long as they pay the annual dues, but more people could join and enjoy the club. The board discussed the idea and decided that adding 50 more new members for 2020 would be considered.

Bill Chin – It will be 25 years on Nov 2 that the Military Match has been held. He would like to request the use of the kitchen for their last match on the 2nd. Also, asked for funds to purchase reward plaques in the amount of \$350.00 for 18 plaques.

10.8.19 d. Motion to approve \$350.00 for award plaques and the use of the kitchen after their shoot.

Motion seconded and passed

Dave Bonner – Had some receipts to turn in for reimbursement – Carla will email to Loren. He asked why the club is planting trees on the Northside of the property. The board explained that it was to create a barrier on that edge of the club property since the property next to the club has been sold for an RV storage facility. He then asked if the cover on the 100-yard range was going to be fixed. He was told yes it would be fixed next week. He also wanted to know if he could get his Range Activity Schedule approved as soon as possible, so that he can get his schedule out. The forms are due by Nov. 8th. The board said that yes, they could get them approved by the end of the year.

VII. OLD BUSINESS

Financial Report – AGC President, Tom Desmond - September revenues were \$22,518 and our expenses were \$29,004 leaving a loss of (\$6,485). Our YTD revenue is \$200,714 and our YTD expenses are \$243,319 leaving a loss of (\$42,605). Account balances: Checking Account \$53,749; Payroll Account \$10,296 and Savings Account \$341,572. Bank of the West money market account \$149,842; Edward Jones CD \$201,426; Bank of the West CD \$202,079.

Maintenance Update – AGC President, Tom Desmond – On Oct 14th the posts will be replaced on the 100-yard shelter and the range will be closed during this time, an email will be sent out to members to notify them of the closure. There is a split in the countertop in the kitchen and Barry Patton has made arrangements to have it looked at. Richard stated that he also knew someone that can repair the counter. The trees will be available in the Spring to purchase, which is also the best time to plant them. The signs that were placed at the beginning of the berms are very specific about where shooters should be shooting. However, some of them need to be moved and they should be placed on both sides of the berms. It has been suggested that refrigerator needs to be replaced due to insufficient freezer space or to add another freezer. David Faingold priced some from a scratch and dent factory and found one for \$1,000. Another option would be a refrigerator/freezer that a member found for \$600.00 new.

10.8.19 e. Motion to purchase a new refrigerator with a cap price of \$1,000.

Motion seconded and passed

Update on Storage Sheds for Shotgun Targets – AGC President, Tom Desmond - We received a quote on a Tuft Shed for \$4,537.00. The shed is a 10 x 12 which is the largest we can do without a permit. Tuft shed will come on site and build it. Home Depot will send it in a box to be assembled. The location being talked about was to put it where the pile of steel is currently being kept and should only take up about the same space.

10.8.19 f. Motion to approve the purchase of the Tuft shed and not exceed \$5,000.

Motion seconded and passed

Ladies Target Shoot - Carla Smith – Had received an email from member, Anne Draper, who is organizing the Ladies shoot for next June. She had a few questions: 1) What will the hourly rate be for the AGC range officers? The board discussed splitting the cost, waiving the cost, or including it in a per person fee. It was decided that a \$5.00 fee per lady shooting would cover the cost of the RO's, the use of the clubhouse and the 2-3 berms. 2) Her next question was about bring food, box lunches, out to the clubhouse. The board said yes. 3) Asked about a microphone system and if one would be available to use in the clubhouse. The board discussed possibly having them use the one that trap uses. 4) Also, wanted to know if they could move some of the tables from the Education Trailer into the clubhouse and move them back when done. The board said yes.

10.8.19 g. Motion to approve the ladies shoot on the 4th Sat. of June and for the club to supply the Range Officers, clubhouse and berms at \$5.00 per person

Motion seconded and passed

VIII. NEW BUSINESS

Incident Report – CRO Terry Humbargar was not in attendance – A member stated that there was an incident on the silhouette range that was not reported. The board explained that not all incidents are reported if they are immediately taken care of. Pete stated that there were a few people shooting centerfire rifles during PSAC in berms 1 & 7 at the steel targets and when asked to stop they did.

Alternative Target Stands – 1st VP, Chris Baker – Brought a sample of an aluminum stand that could be used instead of the tires and concrete. Cost to build each stand would be around \$20.00. Putting a cement disc in the ground that the base of the stand could be bolted to and then attach the target stand piece to it. Would like to try something different than what is out there. There are 29 shooting stations on the 100-yd range. Would like to discuss more options.

Review of November Calendar – Approved

IX. ROUND TABLE

Dave Leiker announced that he will not be here for the Nov. meeting and assigned his proxy to Tom Desmond. Mel Caraway will also not be at the Nov. meeting and assigned his proxy to Michael Quiring. Michael said that he would be Hunting Oct 31st – Nov. 9th and would not be responding to emails during this time.

Tom Desmond - Tested the online payment process to make sure that everything was working for the renewal period. He could save a nickel per transaction with Chase, and may look into that for the following year, but would not be changing anything for the 2020 renewal. He updated the email reply to stress to members that they must complete paperwork and send it back in for their membership to be completely renewed. Said that they needed to remind new clubhouse staff that they are not to accept renewals at the counter. Questions regarding the cameras - our member electrician is going to put some boxes on the side of the clubhouse - the boxes will supply power to the cameras as well as be a mounting point for the cameras. We need that work done before the additional 3 cameras (parking lot, Berm 1 and Berm 2) are available.

Dietrich Whiteside – During the work party he painted lines on the asphalt for the Action pistol match. There is a match exception to shoot from the painted lines.

Manny Boyd – Stated that the line comes out of the berm a bit and he had a member express concern about this and asked about possibly extending the berms out or putting up something to deflect the bullets. Talked about it being Christmas party time - \$2,000 will be spent on 3 guns (handgun, rifle, shotgun) that only full members will be eligible to win. Other prizes will also be given out. The Christmas party is on Sat. Dec. 7th. Would like to request the same amount as last year of \$1,000 to spend on other items in addition to the \$2,000 that will be spent on the guns.

10.8.19 h. Motion to approve the same amount for the Christmas party as last year of \$1000.

Motion seconded and passed

A member asked about being able to purchase AGC items out of the cabinet during the week. Tom informed him that the sale has to be run up through the register and therefore can only be purchased on the weekends when a staff member is working. The member also, wanted to know if something could be setup to purchase trap tokens other than on weekends. Tom said possibly some type of dispensing machine might be an option to look at.

Pete Benoit - Wanted to know if anyone had ever been kicked out of the club? Yes, most recently there was a member kicked out earlier this year.

We also offered the Ambidextrous Plates as an option as we only had 11 shooters (12 guns). The plan still needs a little tweaking but I think we can get it to work.
